Permit Application Process

- 1) Submission window
 - <u>INITIAL</u>: 30-day period following effective date of rules
 - EVERY FOLLOWING YEAR: October 1 November 30 of each year
- 2) DAR will review on a rolling basis
 - Inform applicants if any additional information is needed within a reasonable time
 - If all requirements are fulfilled, DAR sends "statement of preliminary approval" letting the applicant know that their application has fulfilled all the necessary requirements
- 3) DAR final review of all applications collectively (post November 30)
 - Make sure applicant information is still valid (i.e. no resource violations, valid CML, etc.)
 - Finalize ACLs
- 4) Send approved permits with T&Cs, ACLs, and reporting forms to applicants by 12/31

Permit Application Requirements

- 1) Valid CML req'd
- 2) HEPA compliance req'd
 - If an EA or EIS is completed by a group or organization, the organization must apply on behalf of any individuals they designate to be covered under their FEA/FONSI or FEIS.
- No criminal resource violation convictions within the last 5 years

General (State) Permit Terms and Conditions

- 1) Valid for 1 yr
 - <u>INITIAL</u>: Date of issuance December 31 of the same year
 - EVERY FOLLOWING YEAR: Jan. 1 Dec. 31
- Non-transferrable (Permit and Geographical Endorsement) and only useable by permittee
- 3) Allowed to use fine mesh AQ nets and traps
- 4) At Sea Report req'd (before landing)
- 5) Transfer to Registered Commercial AQ Dealer req'd (Before submitting final report)
- 6) Final Report req'd (1 day after landing)
- 7) Container labeling requirements (Taken from WHRFMA rules (HAR ch. 13-60.4))

We s t H a Geographical Endorsement

- No take at night (may possess restricted gear with prior notification) (Taken from WHRFMA rules)
- 2) White list and ACLs

- 4) Export Report Req'd
